

MEDI-CAL PROGRAM

Monthly Public Data Report

Medi-Cal is California's federal Medicaid program. This is a public insurance program which provides needed healthcare services for low-income individuals including families with children, seniors, persons with disabilities, foster care, pregnant women, and low-income people with specific diseases such as tuberculosis, breast cancer, or HIV/AIDS.

CALFRESH PROGRAM

Monthly Public Data Report

CalFresh also known federally as the Supplemental Nutrition Assistance Program (SNAP) provides monthly assistance for low-income or no-income individuals and families to buy food. CalFresh is issued monthly on an Electronic Benefit Transfer (EBT) card, similar to an ATM card, to purchase food at online retailers, grocery stores, convenience stores, farmers markets and any store that accepts EBT.



IN-HOME SUPPORTIVE SERVICES (IHSS)

Monthly Public Data Report

The In-Home Supportive Services (IHSS) program provides in-home assistance to eligible aged, blind, and disabled individuals as an alternative to out-of-home care and enables recipients to remain safely in their own homes.



AREA AGENCY ON AGING (AAA) – HOME DELIVERED MEALS

Monthly Public Data Report

The Home Delivered Meal Program provides nutritious meals to older adults age 60 years and older who are not able to attend congregate meal sites. For those who are unable to leave their home, this program is often the first in-home service that an older adult receives and is a primary access point for other home and community-based services.





Data Source: Reports of number of consumers is generated from SAMS. This is the number of home-delivered meals (by consumers) in the 2022 calendar year by month. The total number of meals served in the 2022 calendar year was 215,670.





ADULT PROTECTIVE SERVICES (APS)

Monthly Public Data Report

Sonoma County Adult Protective Services (APS) receives and investigates reports of suspected abuse or neglect involving older adults age 60+ and adults with disabilities ages 18-59 via a 24-hour hotline. When a report of suspected abuse becomes an investigation, APS assesses clients' unique needs, then works with them to develop a service plan to maintain their safety, health and independence.

FOSTER CARE PROGRAMS

Monthly Public Data Report

The Sonoma County Family, Youth and Children's Division ensures the safety and wellbeing of children, youth, and families in our communities. We provide culturally sensitive, inclusive, and trauma informed services and resources with the goal of ensuring supportive placements, temporary shelter care, and permanency. Foster care (also known as out-of-home care) is a temporary service provided by the States for children who cannot live with their families. Children in foster care may live with relatives or with unrelated foster parents. Foster care can also refer to placement settings such as group homes, residential care facilities, emergency shelters, and supervised independent living.



SONOMAWORKS (CALWORKS/TANF)

Monthly Public Data Report

SonomaWORKS – known statewide as the California Work Opportunity and Responsibility to Kids or CalWORKs program – provides temporary help in the form of cash assistance for families with minor children who have little or no money. SonomaWORKS can also help qualifying adults build skills toward getting and keeping a job to support their family.



GENERAL ASSISTANCE (GA)

Monthly Public Data Report

General Assistance provides temporary cash assistance to individuals (typically ages 18+) who have little or no money, to help with meeting basic needs. General Assistance can be approved for up to 90 days in a 12-month period, and possibly longer for people with disabilities. Assistance may be available to help pay a landlord for rent or pay utilities. Through Sonoma County Job Link, individuals can also get support with preparing for or finding a job.

JOB LINK - WORKFORCE INNOVATION & OPPORTUNITY (WIOA) ACT

Monthly Public Data Report

Job seekers who need assistance with finding a job, changing career paths, or improving job skills may be eligible for Job Link individualized career services. One-on-one career counseling is available for both adults and youth/young adults (ages 16-24). For job seekers who qualify, financial assistance can be used to enroll in training and/or classes (e.g. college or a training school), and pay for course fees, books, and other materials.
